

Excellence In Quilts Call for Entry, May 1 through May 31, 2023. This juried exhibition will appear in the fall issue of *Fiber Art Now*, to be released in early October 2023. Juried selections will be eligible for the onsite exhibition at the Texas Quilt Museum, La Grange, Texas, May 2, 2024 through August 31, 2024. Artists are invited to enter 2D and 3D innovative artwork of original design, hand or machine quilted. Two-dimensional quilts should measure more than 24 inches in either direction and be no larger than 90 inches in either direction. Quilt sleeves should not be smaller than three (3) inches and no larger than four (4) inches and should span the full width of the quilt. The Texas Quilt Museum has their own hanging system with rods, so rods are not needed. Framed quilts are not eligible. The quilts must be available April 2 through September 30, 2024. We are fortunate to have award-winning quilt artist and renowned teacher Sue Benner as the juror.

Submit entries to CaFÉ Call for Entries, May 1 through May 31, 2023 midnight mountain standard time (MST). If you do not have a CaFÉ account, you will need one to enter. There is no charge to open a CaFÉ account. If you have questions about starting a CaFÉ account, contact CaFÉ, [How to Apply for Artists | CaFÉ™ - CallForEntry.org](https://www.callforenry.org).

A discounted entry fee is available to *Fiber Art Now* subscribers and the discount code will be emailed to subscribers prior to May 1. Artists may submit up to three individual works of art as full images only. Detail images will not be accepted for this Call for Entry.

Notifications will be emailed on or before June 30. Artists who enter more than one artwork will receive two different notifications, one for the invited work, and another for the work(s) that were not invited. Juried selections will include only one artwork per artist. Prizes will be awarded for 1st \$300, 2nd \$250, and 3rd \$200 selections.

Entries will not be accepted after May 31 midnight mountain standard time (MST). The CaFÉ Call for Entry will close at that time.

Note that CaFÉ does not let you go back into your application to make changes or corrections. Please review your entries before checking out. If you need to make changes or corrections after you have paid your entry fee, you will need to start a new application to enter the information for all entered artwork.

Entries must be File Type: JPEG or JPG only.
File Dimensions: 1,200 pixels or greater on the longest side.
File Size: Under 5 MB.
Color Profile: sRGB

You will need to enter the information for each piece separately, starting with the title of the piece. List each piece separately in the same space required for artist statement, materials, techniques, photographer, etc., beginning with the title of the artwork. For example, if you are entering three separate works, for the Artist's Statement, you will have the TITLE of the first piece followed by the artist statement for that piece, next the TITLE of the second piece followed by its artist statement, then the TITLE of the third piece followed by its artist statement, all in one space.

The same format works for every space.

For materials, etc. you will list the TITLE of the first piece followed by the materials, next the TITLE of the second piece followed by its materials, then the TITLE of the third piece followed by its materials. All of that information is entered into the same space for materials.

List dimensions as Height x Width x Depth.

International *Fiber Art Now* subscribers are eligible to enter *Excellence In Quiltss*. International nonsubscribers are also eligible to enter. Non-English speakers will need to have their entry translated before applying through CaFE.

Notification of INVITED or NOT INVITED will appear in your CaFÉ account after the jurying has been completed. You will receive a notification from CaFÉ with acceptance or regrets. Multiple submissions may receive two different email notifications. Email notifications will list each artwork as Invited or Not Invited. Please check SPAM for notifications if they do not appear in your email.

Entry fee: \$30 for up to three entries. *Fiber Art Now* subscribers: \$20 with the discount code EIQ2023. Use the discount code at check out. Entries close at midnight Mountain Time Zone, USA. **CaFE does not let you go back into your application to make changes or corrections. Review your entry before checking out.**

Fiber Art Now reserves the right to make final decisions on all juried submissions. Entry fees are non-refundable. The artist certifies they hold the copyright for the artwork and its image. The artist also certifies the work submitted is original and does not infringe on any existing copyright. If artwork includes an image of any person, the artist certifies that a model release has been obtained. *Fiber Art Now* will attribute the name of the artist whenever images of the artwork are used by *Fiber Art Now* for print and /or digital promotion. The artist grants permission for *Fiber Art Now* to use the submitted images for promotion in print and /or digital media.
